General Evaluation of Program/Success/Challenges

The 2012-2013 year faced some challenges for our program as we saw two of our daycare facilities close their doors at the end of last year's contract and one major facility close down due to financial issues in the first few months of this contract. Several home providers are still not responding to our services when invited. However, with the addition of the Early Childhood Centers and two religious academic preschool programs we have been able to increase the number of children served in our community. Providing on site trainings to staff at the end of their work day provides convenience to those attending and assures facilities their hours are being met. Being able to provide trainings to one individual in this year's contract made it easier for those at the end of the calendar year to catch up if they missed earlier trainings. Our local **Children Ready to Enter School Coalition** provided a 12 hour workshop for providers at the beginning of the 2013 calendar year, which reduced how many relied on our program for trainings. Child Care Aware has also provided trainings on autism, and classes are available at the local community college on various topics. However, our program still is the only one who provides trainings for free.
